

CASH BACK PROMOTIONS TERMS AND CONDITIONS

1. Information on how to participate in the Cash Back promotions, details contained within promotional materials and Buyer Terms and Conditions form part of these Terms and Conditions.
2. Participation in the promotion is deemed as acceptance of these Terms and Conditions.
3. The promotion starts and concludes on the dates stated in the promotional material ("**Promotion Period**").
4. To be eligible to participate in the promotion, you must:
 - a) be an Australian resident aged 18 years or above;
 - b) provide an Australian postal address;
 - c) be a registered member of BuyMeStuff ;
purchase a participating product during the Promotion Period from BuyMeStuff Pty Ltd (ACN 168 998 721) trading as www.buymestuff.com.au ("**BuyMeStuff**");
 - d) the minimum purchase price should be \$100 and above per product unless stated otherwise; and
 - e) the product must have been paid for in full within the Promotional Period ("**Eligible Customer**").
5. The Cash Back is limited to a maximum of three (3) per registered member during each Promotional Period provided the purchase is of a participating product.
6. Cash Back will only be available for a limited period for the first one hundred (100) Eligible Customers or until stock lasts whichever comes first. Eligible Customers acknowledge and agree that, from time to time there may be no offers available under these Terms and Conditions.
7. BuyMeStuff reserves the right to request Eligible Customers to provide proof of identity, delivery address and/or proof of purchase in order to claim the Cash Back. Proof of identification considered suitable for verification is at the discretion of BuyMeStuff. In the event that an Eligible Customer cannot provide suitable proof, the Eligible Customer will forfeit the Cash Back in whole and no substitute will be offered.
8. Upon verification of the identity and eligibility of the Eligible Customer, a Cash Back payment to the value advertised for the Promotional Period will be made into the Eligible Customer's nominated account with PayPal Australia Pty Limited (ABN 93 111 195 389) ("**PayPal**") within fourteen (14) business days subject to these Terms and Conditions. BuyMeStuff will not exchange the payment for cash or any other payment method. BuyMeStuff will only make the payment to the same PayPal account from which the participating product was purchased. The payment will be made in Australian Dollars.
9. The Cash Back or the legal or beneficial interest in the Cash Back cannot be transferred or assigned and cannot be redeemed for anything other than the Cash Back payment made to the Eligible Customer.

10. Should an Eligible Customer's contact details change during the Promotional Period, it is the Eligible Customer's responsibility to notify BuyMeStuff. A request to modify the information should be directed to BuyMeStuff.
11. BuyMeStuff reserves its rights to accept, refuse or reclaim the Cash Back if, at the time of processing or subsequently, BuyMeStuff discovers that the eligibility of the customer at the time of purchase or delivery was not valid or legitimate.
12. BuyMeStuff reserves the right to verify the validity of the purchase and identification of Eligible Customers, and to disqualify any Eligible Customer which, in the opinion of BuyMeStuff, has tampered with the Cash Back claim, submits a claim that is not in accordance with these Terms and Conditions or who has, in the opinion of BuyMeStuff, engaged in conduct in entering into the promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the promotion and/or BuyMeStuff.
13. BuyMeStuff reserves the right in its sole discretion to disqualify any individual who BuyMeStuff has a reason to believe has breached any of these Terms and Conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of any promotion. BuyMeStuff's legal rights to recover damages or other compensation from such an offender are reserved.
14. To the extent permitted by law, BuyMeStuff may, at its discretion, provide the Cash Back to customers who do not comply with these Terms and Conditions.
15. In the case of the intervention of any outside act, agent or event which prevents or significantly hinders BuyMeStuff's ability to proceed with the promotion on the dates and in the manner described in these Terms and Conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, BuyMeStuff may in its absolute discretion cancel the promotion and recommence it from the start on the same conditions, subject to any written directions given under applicable laws.
16. If for any reason a promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of BuyMeStuff, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, BuyMeStuff reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, and may take any action to cancel, terminate, modify or suspend the promotion, subject to any applicable laws.
17. If for any reason a promotion (or part of a promotion) is unavailable, BuyMeStuff , at its sole discretion reserves the right to substitute the offer (or that part of the offer) with an offer of equal value and/or specification. BuyMeStuff also reserves the right to add, remove, modify, reschedule, extend or terminate (in whole or in part) the available promotion and the promotion criteria at its discretion. In the event there are any changes to an order, BuyMeStuff will attempt to notify you via telephone, email and/or billing address provided at the time the order was made.

18. BuyMeStuff is not responsible for any costs incurred by the Eligible Customer in participating in the promotion or an Eligible Customer's inability to access the internet or email.
19. Independent financial advice should be sought as to tax implications that may arise as a result of accepting the Cash Back.
20. BuyMeStuff reserves the right to vary these terms and conditions without notice.
21. BuyMeStuff's decision on all matters pertaining to a promotion is final and binding and no correspondence will be entered into.

BuyMeStuff is not responsible for any incorrect or inaccurate information, either caused by the Eligible Customer, or for any technical error, or any combination thereof, that may occur in the course of the administration of any promotion including any omission, interruption, deletion, defect, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access, and reserves the right to take any action that may be available.
